**2. ELIGIBILITY:**

You must comment on your prize selection “LAGUNA SUPER or LAGUNA REVO” prior to the end of the Contest Period, then you will automatically be granted one (1) Entry (the “**Entry**”) in the Contest.

**4. ENTRY LIMIT:**

There is a limit of one (1) Entry per person. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) obtain more than one (1) Entry; and/or (ii) use multiple names, identities, email addresses, and/or any automated, macro, script, robotic or other system(s) or program(s) to enter or otherwise participate in or disrupt this Sweepstake; then he/she may be disqualified from the Sweepstake in the sole and absolute discretion of the Sponsor. The Released Parties (defined below) are not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries (all of which are void). All Entries are subject to verification at any time and for any reason. The Sponsor or its designated representative will make a minimum of three (3) attempts to contact each selected entrant within five (5) business days of the applicable Draw Date.
